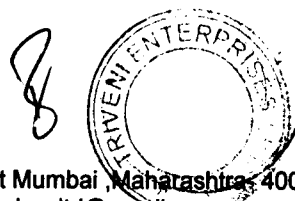
1. Approved Audited Standalone Financial Results of the Company for the quarter and year ended on March 31, 2019.

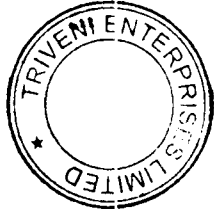

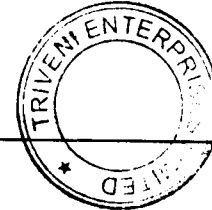

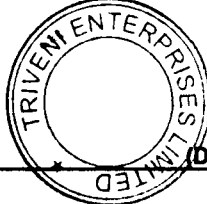
